**RULES**

1. Contestant must have reached their 16th Birthday and cannot have reached their 22nd birthday by October 31st of the current year. The winning contestant must show proof of age at the state Miss Kentucky County Fair Pageant in January.
2. Contestant must be single, never married, and never have had children.
3. Contestant must be a permanent resident of the state of Kentucky.
4. Contestant must be born a natural female.
5. Contestants will be judged from the standpoint of personality, poise, and appearance.
6. Judges' decision are final.
7. Previous winners are not eligible to compete.
8. The winning contestant will be expected to retain her title until the following year, marriage or motherhood constitutes loss of title.
9. Failure to comply with the fairboard or pageant committee and their rules and
10. regulations may result in dismissal from the pageant.
11. The winning contestant must attend opening day ceremonies at the Kentucky State Fair to accompany the Little Miss/Mister in August, she will also be expected to compete in the Miss Kentucky County Fair Pageant to be held the following January.
12. Suitable prizes will be awarded to winners.
13. Contestants may not compete in any pageant system that would prohibit the fulfillment of responsibilities through the state during her reign as a pageant title holder.
14. All rules are in compliance with the Kentucky Association of Fairs and
15. Horseshows.
- 16. No males allowed in dressing area.**
17. If able, the winning contestant is to come to the fairgrounds/and or another location in Bardstown for a practice mock interview before the state pageant in January of the following year.
